- Motion to approve. First Val, second Ed. No-one opposed. Motion carried.

## 2. Online Application for the PAC

- Sarah reviewed.
- Application could be updated to include FN as well.
- Val, form looks good. Perhaps add a note that the position is unpaid in the online application.
- Motion to approve, First Val, second Fawn. No-one opposed. Motion carried.
- Sarah, need to establish the process for reviewing and selecting the applicants for the PAC. Preference is to have some municipal feedback. Ed, likes the idea of relying on local Working Group members to comment on the applications. Brent, decision making process will be complicated. Sarah, perhaps the Consulting Team reviews and makes recommendations back to the Working Group. Consult with Working Group as needed for feedback before coming back to the Working Group with a recommendation.
- Pete: suggests bringing back recommendation to Working Group via a Teams call in February for discussion.

- Jody: we should be clear about the number of applicants. Sarah, yes it will be noted. Jody, composition is outlined in the ToR (section 4.0).
- Pete: suggests time for the application to be open is ~3 weeks, supported by group. Will try to start and finish in January. Sarah, we will have another virtual meeting in February to review recommendations.
- Motion to accept application process, Val first, second Fawn. None opposed.

#### 3. Other Business

- Sarah reviewed the FAQs. One edit required on the name.
- Brent: will we have a project logo on the top? Now it is the biosphere. Yes, once logo is complete.
- Val, any information for landowners to help deal with erosion challenges. Nonstructural solutions. Lake Huron Coastal Centre and Elgin County SMP had suggestions. Add something about 'Refer to the website for information on dealing with natural hazards'.
- Jody, shared link from LHCC, which has information. Would need to customize to be representative of the littoral cell.
- Ed, Elgin County SMP was not fully endorsed. Therefore, don't reference the full SMP, just use the relevant information.
- Fawn: what was the concern with the SMP. The SMP recommended managed retreat for the eroding shoreline, not further hardening. Some landowners took exception to this recommendation, and it was not approved by all CAs.
- Fawn: is there any assistance for landowners dealing with erosion challenges. Val, used to be a funded program to move homes threatened by erosion. 50% funding. Program was cancelled when the Harris government took office.
- Fawn: is there a prediction model on the rate of future land loss due to erosion? Val, CAs have setback requirements and mapping. Harder to deal with existing development. Sarah, there is strong resistance to being relocated when threatened by erosion. Fawn, best solution would be purchasing and naturalizing. Val, cost of properties is prohibitive. Pete, will look at property and building vulnerability next FY, starting in April.
